## Adventure Sports II Inc. Complete Trip Liability Release

I Understand the purpose of signing this document is to exempt and release Adventure Sports Inc., Adventure Sports II Inc., Adventure Sports SCUBA School Inc., SSI, NASDS, PADI SCUBA Programs, Instructors, Assistant Instructors, Teaching Aides, Employees, Agents, Subcontractors and Boat (whether owned, operated, leased or chartered) and to hold these entities harmless from and all liabilities arising as a consequence of the following, or any other acts if omissions on their parts, including but not limited to negligence.

- Initial – \_\_\_\_\_

I am a certified diver or a student diver under the direct or indirect supervision of an instructor or dive guide and have been taught and understand SCUBA diving has inherent risks and dangers associated herewith including, but not limited to, risks associated with equipment failure, perils of the sea, acts of fellow divers and I specifically assume such risks.

I acknowledge that I am physically fit to SCUBA dive and snorkel and I will not hold any of the above named responsible if I am injured as a result of heart problems, lung problems, or other illnesses or medical problems which occur while diving and/or snorkeling.

- Initial – \_\_\_\_\_

I do not have in my possession any illegal drugs, nor am I taking, nor have I recently taken, any drugs or medication that would contraindicate diving. I have not used any intoxicating liquids prior to diving and I understand the dangers of drinking any intoxicating liquids or using illegal drugs prior to diving.

- Initial – \_\_\_\_\_

Prior to leaving the dock, I will inspect all equipment to be used. I will notify the appropriate divemaster/instructor/crew member if any equipment is not functioning properly.

- Initial – \_\_\_\_\_

I will be present at and attentive to the safety briefing given by the boat captain and if there is anything that I do not understand or have been taught differently, I will notify the boat captain immediately.

- Initial – \_\_\_\_\_

I understand I have a duty to plan and carry out my own dive and to be responsible for my own safety and the safety of my buddy. **I will remain with my buddy at all times.**

- Initial – \_\_\_\_\_

I will start my ascent at the end of each dive with enough air to guarantee being on the boat with a minimum of 500-PSI remaining in my tank.

- Initial – \_\_\_\_\_

I will immediately stop my dive if 1) I feel uncomfortable with my diving ability, and/or 2) diving conditions are worse than those for which I have been trained or for which I have experience.

- Initial – \_\_\_\_\_

I am aware of the dangers of holding my breath while diving and of the dangers associated with rapid ascents and will not hold the above named persons or entities responsible for such acts.

- Initial - \_\_\_\_\_

If I become distressed on the surface, I will immediately drop my weight belt and inflate my BC for permanent flotation assistance and if I want or need assistance from the boat, I will give the proper "diver in trouble" signal.

- Initial - \_\_\_\_\_

I fully understand and am aware that the dive boat has limited medical facilities and that in the event of illness or injury, appropriate medical help must be summoned by the radio and that treatment will be delayed until I can be transported to a proper medical care facility.

- Initial - \_\_\_\_\_

I understand I will be diving at remote dive sites and that a recompression chamber may not be readily available. I do wish to continue with this dive and personally assume the risk of diving in the absence of a recompression chamber.

- Initial - \_\_\_\_\_

I understand I incur financial responsibility for deposits and all monies paid towards this trip. I understand no refunds of deposits or monies paid whether by cash, check, or credit card will be made. Nor will I be able to transfer any monies paid to another trip.

- Initial - \_\_\_\_\_

I understand that any SCUBA equipment used on the trip must have proof of a current annual service e.g. CIP, BCP or receipt with serial nos. If said proof cannot be presented, then I understand that I will not be allowed to use that equipment.

I understand that the sport diver limit is 130 feet. I agree not to exceed that depth or the depth required by the Dive Master. I assume all risk associated to exceeding maximum depth limits.

**It is my intention by this instrument to give up my right to sue all persons or entities referred to herein, whether specifically named or not, and it is also my intention to exempt and relieve Adventure Sports Inc., Adventure Sports II Inc., Adventure Sports SCUBA School Inc., SSI, NASDS, PADI SCUBA Programs, Instructors, Assistant Instructors, Teaching Aides, Employees, Agents, Subcontractors and Boat (whether owned, operated, leased or chartered) and to hold these entities harmless from any and all liability for personal injury, property damaged or wrongful death caused by negligence or gross negligence and I assume all risk in connection with Snorkeling and SCUBA diving activities.**
